Green finance post-COP29 Pathways for delivery

Developing transparent, accountable, and innovative financial models to address climate change could foster inclusive growth while ensuring sustainable development in the region. Green finance should ensure that the most vulnerable communities can benefit from climate financing to build a climate resilient economy in South Asia.

Annually 400,000 people die due to the climate crisis and every 50 seconds, a person dies as a result of climate-induced disasters. The Global Humanitarian Report of 2024 states that 350,000 people lost their lives in 2023, which is a grim reminder of the consequences of inaction on climate change. From 2019 to 2023, approximately 81 million people in South Asia were affected by climate-induced floods and other disasters. South Asia is sitting on a time bomb and the poorest communities are the most affected. With agriculture contributing 17 percent of South Asia's GDP and 42 percent of its population employed in this sector, climate change will have a profound impact on livelihoods, food security, and economic stability in the region.

Keeping the idea of South Asia regional integration alive

A conference is ultimately as good as its participants. The Fifteenth South Asia Economic Summit (SAES), held in Kathmandu on 11-13 December 2024, is no different and does not disappoint. From the deliberations in 17 sessions involving over 100 participants from across South Asia and beyond, including close to 50 from outside of Nepal, emerged a picture of South Asia deeply concerned about environment damage and the effects of climate change, concerned by a green finance crunch imposed on the vulnerable, gripped by a foreboding of the industrial and trade policy measures emerging in the wake of climate action and propelled by geopolitical rivalries, and alarmed by the inequality worsened by climate change, while also confident of unleashing an equitable green transformation by building on some positive actions already taken by governments, the private sector and civil society.

The inaugural session set the tone for the agenda of equitable green transformation for the rest of the summit, with distinguished speakers emphasizing the need for a greater regional cooperation and how a regional clean electricity market is indispensable for an equitable green transformation in South Asia.
